

# **Invitation to Bid for the Design and Construction of 350 Cubic Meter Capacity Glass Fused to Steel Bolted Tank Expandable to 700 Cubic Meter**

1. The TALAVERA WATER DISTRICT (TWD) through the Corporate Budget for the contract approved by the Governing Board for the year 2024 intends to apply the sum of **Nine Million Pesos(Php 9,000,000.00)**being the Approved Budget for the Contract (ABC) to payments under the contract for **Bid for the Design and Construction of 350 Cubic Meter Capacity Glass Fused to Steel Bolted Tank Expandable to 700 Cubic Meter**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. TWD now invites bids for **Bid for the Design and Construction of 350 Cubic Meter Capacity Glass Fused to Steel Bolted Tank Expandable to 700 Cubic Meter**. The tank shall be made of Glass Fused to Steel wall panels, Self-supporting Roof, reinforced concrete floor and foundation with required inlet/outlet/overflow connection flanges, drain sump and other related appurtenances.

Completion of the Works is required **October 11, 2024**. The Prospective Bidders must have experience of having completed a contract similar to the Project, equivalent to at least fifty (50%) of the ABC adjusted to current prices using the National Statistic Office consumer price index. The description of an eligible bidder is contained in the Bidding Documents, particularly, in

## Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
5. Interested bidders may obtain further information from TWD and inspect the Bidding Documents at the address given below from **9AM to 4PM**. Monday to Friday. August 19-31, 2024

A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Ten Thousand Pesos (Php 10,000.00)**.

It *may also be downloaded* free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.



7. Bids must be delivered to the address below on or before **03 September 2024, 2PM** at **TWD Conference Room, TWD Building, Talavera Water District, Talavera, Nueva Ecija**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. TWD reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
