Invitation to Bid

“Invitation to Bid for the Design and Construction of 700 Cubic Meter Glass Fused to Steel Bolted Tank with Steel Floors

1. The *TALAVERA WATER DISTRICT*, through the *Corporate Budget for the Year 2025* intends to apply the sum of ***Thirteen Million and three hundred thousand Pesos (P13,300.000.00)*** being the Approved Budget for the Contract (ABC) to payments under the contract for **“Invitation to Bid for the Design and Construction of 700 Cubic Meter Glass Fused to Steel Bolted Tank with Steel Floors**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *TALAVERA WATER DISTRICT* now invites bids for the above Procurement Project. Completion of the Works is required ***Ninety Days (90) calendar days from receipt of Notice to Proceed***. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary *“pass/fail”* criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *TALAVERA WATER DISTRICT* and inspect the Bidding Documents at the address given below from ***9:00 AM to 4:00 PM, Mondays to Fridays except Holidays***.
5. A complete set of Bidding Documents may be acquired by interested bidders on ***Oct 29-Nov 10, 2025*** from the given address and website/s below and ***upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Ten Thousand Pesos (P10,000)***. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
6. The *TALAVERA WATER DISTRICT* will hold a Pre-Bid Conference on ***October 28, 2025, 02:00 P.M*** at *TALAVERA WATER DISTRICT, 042 Diaz St., Pag Asa District, Talavera, Nueva Ecija*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the ***042 Diaz St., Pag Asa District, Talavera, Nueva Ecija*** on or before ***Nov 10, 2025, 02:00 P.M.*** Late bids shall not be accepted.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
9. Bid opening shall be on **Nov 10, 2025, 02:01 P.M. at 042 Diaz St., Pag Asa District, Talavera, Nueva Ecija**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The *TALAVERA WATER DISTRICT* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
